 - c) copy of the page of your most recent tax return showing number of dependents/household members and gross household income. (Social Security numbers may be blacked out for privacy.)

Guidelines for Financial Assistance:

1. Financial assistance is available for class & A.M.P. Camp tuition only (unfortunately not for private lessons & class materials/registration)
2. The person applying for financial assistance must be:
 - a. Able to claim the applicable student(s) as a dependent on his/her tax return
 - b. Able to produce a tax return or other document that proves income and lists all dependents.
3. If both parents live together and file taxes separately, both parents must submit their tax returns.
4. Financial assistance paperwork must be complete & approved before a student may begin a class. The deadline to apply for financial assistance for Winter/Spring Session 2016 is **Fri. Apr. 1**. The deadline to apply for financial assistance for Spring Session 2016 is **Wed. Apr. 13**. For Spring Session 2016, financial assistance is only available for classes with 3 or more students.
